



Higher Risk Of Injury

Due to specific factors that categorise my pet as having a higher risk of injury or health issues compared to the average pet, including matting/pelting, old age, and specific health conditions, I, as the owner of the pet, acknowledge and agree to the following terms with Purrs and Furr Cat Grooming

Elderly or Health-Impaired Cats

I understand that any grooming performed on an elderly cat or a cat with health problems is at my own risk.

Grooming may reveal pre-existing health and/or skin problems for which Purrs and Furr Cat Grooming cannot be held liable.

Elderly cats, due to thinner, drier, and less elastic skin, are at a higher risk of nicks and cuts during shaving. The lack of muscle tissue for cushioning can further complicate the shaving process.

Dematting/Detangling

I consent to the removal of matted hair with the understanding that it may result in patchiness and hair loss, significantly altering the cat's appearance.

This procedure may expose pre-existing skin conditions for which Purrs and Furr Cat Grooming is not responsible. Severe matting and/or pelting will incur an additional fee.

If at any point during grooming, signs of stress such as panting, anxiety, or excessive movement occur, the groom will be immediately stopped, even if incomplete. A minimum charge of 50% of the agreed-upon fee will be applied.



Higher Risk Of Injury

Health Conditions Declaration

I acknowledge that certain illnesses and conditions, including but not limited to diabetes, heart murmur, hypertrophic cardiomyopathy, hyperthyroidism, seizures, and being overweight, pose a higher risk during grooming.

I am obligated to declare these conditions on consultation forms, accompanied by a veterinary clearance note confirming the cat's fitness for grooming.

Grooming Style Adjustments

I understand that previously discussed grooming styles, such as authorized Lion Cut or Comb Cut, may not be completed due to my cat's health condition.

This decision is made in the best interest of the cat's well-being. I am responsible for payment of any services completed in lieu of the initially discussed styles.

Authorization for Veterinary Treatment

In the event of any injury or health concern, Purrs and Furr Cat Grooming is authorised to contact a vet and authorise necessary veterinary treatment for the cat. I accept full responsibility for all veterinary charges that may arise.
